WHEREAS, the Local Government Code of the Philippines (RA 7160) empowers the Sangguniang Bayan as a legislative body to enact ordinances, approve resolutions for an efficient and effective municipal government and in this connection shall determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from municipal funds and provide for expenditures necessary for the proper conduct of programs, projects, services, and activities of the municipal government;

WHEREAS, in response to the request of the Human Resource Management Office, and after a thorough inquiry and analysis, the Sangguniang Bayan deemed it necessary to create the position of Veterinarian III under the Municipal Agriculture Office appropriating funds therefore and for other purposes;

WHEREAS, considering the funds to be utilized shall be source in FY 2025 appropriation for personnel benefits; hence; herein creation shall not affect the 45% Personal Services limitations;

WHEREAS, having additional personnel is greatly needed by the mentioned office in order to enhance public service.

NOW THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN, IN A SESSION DULY ASSEMBLED, THAT:

Section 1. *Creation of Position.* – There shall be created the position of Veterinarian III, SG-19 under Municipal Agriculture Office in the Municipality of Bustos, Bulacan.

Section 2. *Qualifications.* – No person shall be appointed as Veterinarian III unless he/she have the following qualification standars:

- **Education:** Doctor of Veterinary Medicine
- **Experience:** 2 years of relevant experience
- **Training:** 8 hours of relevant training
- **Eligibility:** RA 1080 as amended (Veterinarian)


Section 3. *Duties and Function:*

- Treat sick or injured animals by prescribing medications, dressing wounds, performing surgery;
- Educate the public about diseases and infections that are transferable from animals to humans;
- Promote the health and wellness of animals by advising animal owners about sanitation measures, feeding and general care;
- Record actions by documenting and updating forms, reports, animal records and reporting diseases to public health offices;
- Ensure compliance with veterinary procedures, ethics, policies and relevant statutes;
- Establish or carry out quarantine or testing procedures that combat the spread of diseases to humans or to other animals according to established government regulations.

Section 4. *Source of fund.* – For FY 2025, the corresponding appropriation for this new created position is from the abolition of vacant position of Municipal Agriculture Officer. For the succeeding years, the Municipality shall allocate funds for this position.


Section 5. *Effectivity.* – This Ordinance shall take effect immediately after approval.
