WHEREAS, Section 3, Article IX-B of the 1987 Constitution recognizes the Civil Service Commission (CSC) as the central personnel agency of the government, and mandates it to establish a professional, efficient, and responsive career service by strengthening merit and rewards systems, integrating development programs, and promoting public accountability;

WHEREAS, the 1997 Qualification Standards Manual issued by the CSC provides the appropriate minimum qualifications for the position of Chief of Hospital I;

WHEREAS, Section 67 and 68 of CSC Memorandum Circular No. 19, Series of 2019, prescribe the training requirements for executive and managerial positions, which shall apply to the position of Chief of Hospital I, given its leadership nature and involvement in the practice of the medical profession;


WHEREAS, it is imperative to amend Section 2 of Ordinance No. 2024-27 to align the qualification standards with current regulations and ensure that the Bustos Community Hospital is led by a competent and well-qualified medical professional.

NOW THEREFORE, BE IT ORDAINED by the
Sangguniang Bayan of Bustos, Bulacan, in session assembled:

Section 1. Amendment to Section 2 of Ordinance No. 2024-27

Section 2 of Ordinance No. 2024-27 is hereby amended to reflect the updated qualification standards for the position of Chief of Hospital I, Salary Grade 24, as follows:

“Section 2. Qualifications. – No person shall be appointed as Chief of Hospital I under the Bustos Community Hospital unless he/she have the following qualification standards:

- **Education:** Doctor of Medicine
- **Experience:** 2 years of supervisory experience
- **Training:** 40 hours of continuing Professional Education/ Development for medical doctor/Physician or technical training on medicine and 80 hours of management training / learning and development interventions
- **Eligibility:** RA 1080 (Medicine)”

Section 2. Implementation and Compliance

The Human Resource Management Office (HRMO) and Local Chief Executive are hereby mandated to ensure strict compliance with the updated qualification standards in the recruitment, appointment, and promotion of the Chief of Hospital I.

Section 3. Funding Provision

Funding for the continued implementation of the position shall be charged against the appropriate annual budget allocation of the Bustos Community Hospital, subject to usual accounting and auditing rules and regulations.

Section 4. Separability Clause


If any part or provision of this Ordinance is declared invalid or unconstitutional, the remaining provisions not affected shall remain in full force and effect.

Section 5. Repealing Clause

All ordinances, executive orders, or administrative issuances inconsistent with this Ordinance are hereby repealed or modified accordingly.

Section 6. Effectivity

This Ordinance shall take effect immediately after its approval and publication or posting in accordance with the provisions of






