

“REQUESTING THE NATIONAL IRRIGATION ADMINISTRATION (NIA) TO ALLOCATE AND DEVELOP AN ALTERNATIVE ROAD CONNECTING THE MUNICIPALITIES OF BUSTOS AND BALIWAG, BULACAN, TO ALLEVIATE TRAFFIC CONGESTION AND IMPROVE MOBILITY IN THE AREA.”

WHEREAS, the municipalities of Bustos and Baliwag are key economic and agricultural hubs in the Province of Bulacan, contributing significantly to the region’s development and food security;

WHEREAS, the current road network connecting Bustos and Baliwag is heavily congested due to increasing vehicular traffic, limited road capacity, and the growing population in the area;

WHEREAS, the National Irrigation Administration (NIA) manages infrastructure and right-of-way areas that could potentially serve as an alternative route to decongest existing roads and provide a more efficient transportation link between the two municipalities;

WHEREAS, the development of an alternative road will not only ease traffic congestion but also enhance the delivery of goods and services, improve emergency response times, and promote economic growth in the region.
