**WHEREAS**, the municipality of Bustos is fully committed in supporting the State’s policy is promoting equal opportunities in employment for everyone specially in:

- a) Promoting employment of individuals on the basis of their abilities, knowledge, skills and qualifications rather than their age;
- b) Prohibition of arbitrary age limitations in employment; and
- c) Promoting the right of all employees and workers, regardless of age, to be treated equally in terms of compensation, benefits, promotion, training and other employment opportunities


