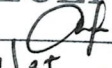

WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991, the LGU shall promote health and safety, and enhance the right of the people to a balanced ecology and persevere the comfort and convenience of their inhabitants;

WHEREAS, Republic Act No. 9003, otherwise known as the “Ecological Solid Waste Management Act of 2000,” mandates the adoption of systematic, comprehensive, and ecological solid waste management programs in every local government unit;

WHEREAS, Barangay Poblacion, Bulacan, has enacted Barangay Ordinance No. 8, S-2024, entitled “An Ordinance Establishing the Ecological Solid Waste Management of Barangay Poblacion, Bustos, Bulacan,” which outlines programs and measures for effective waste management in the barangay;

WHEREAS, the Sangguniang Bayan of Bustos, Bulacan, recognizes the importance of this ordinance in promoting environmental protection, public health, and community well-being;
