“AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HONORABLE FRANCIS ALBERT G. JUAN, TO REPRESENT AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE MUNICIPALITY OF BUSTOS AND THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) RELATIVE TO THE IMPLEMENTATION OF THE ASSISTANCE TO INDIVIDUALS IN CRISIS SITUATIONS (AICS) PROGRAM.”

WHEREAS, Executive Order No. 137, Series of 2021, and Executive Order No. 221, Series of 2023, issued by the Department of Social Welfare and Development (DSWD), institutionalize the Assistance to Individuals in Crisis Situations (AICS) as a social safety mechanism to provide emergency support to individuals and households affected by unforeseen circumstances such as illness, death of a family member, disasters, and other crises;

WHEREAS, the Municipality of Bustos recognizes the critical role of the AICS program in alleviating the suffering of vulnerable constituents and strengthening their capacity to recover from emergencies;

WHEREAS, Section 23 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers local government units to enter into contracts and agreements necessary for the discharge of their functions and delivery of public services;

WHEREAS, the Municipal Government of Bustos, under the leadership of Mayor Francis Albert G. Juan, seeks to formalize its partnership with the DSWD through a Memorandum of Agreement (MOA) to ensure the efficient implementation of the AICS program within its jurisdiction;


THEREFORE, upon motion by **HONORABLE PHILLIP WRYNER B. SANTOS**, and unanimously agreed upon by all the members present.



APPROVED and ADOPTED, 17th day of February, 2025 by the Sangguniang Bayan at the Amado Raymundo Session Hall.


