**WHEREAS**, the Local Government of Bustos, Bulacan recognizes the importance of agricultural development and mechanization to enhance productivity and support local farmers;

**WHEREAS**, Section 22(c) of the Local Government Code of 1991 (Republic Act No. 7160) empowers local government units to enter into contracts and agreements, including donations, to promote the general welfare of their constituents;

**WHEREAS**, the acceptance of such donation requires the authorization of the Local Chief Executive to execute the necessary Deed of Donation (DOD) on behalf of LGU Bustos;

**THEREFORE**, upon motion by **HONORABLE SOLIMAN C. SANTOS**, and unanimously agreed upon by all the members present.


