“AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HONORABLE FRANCIS ALBERT G. JUAN, TO REQUEST TWO (2) FARM TRACTORS AND TWO (2) HAND TRACTORS FROM THE RICE COMPETITIVENESS ENHANCEMENT FUND (RCEF), WITH THE LOCAL GOVERNMENT UNIT OF BUSTOS PROVIDING A SHED AND FUNDING FOR OPERATION AND MAINTENANCE.”

WHEREAS, Republic Act No. 11203 (Rice Tariffication Law) established the Rice Competitiveness Enhancement Fund (RCEF) to modernize the Philippine rice sector and enhance farmers' competitiveness through mechanization, seed development, and credit support;

WHEREAS, Section 5(b) of RA 11203 mandates the provision of agricultural machinery and equipment to eligible farmer-beneficiaries and local government units (LGUs) to improve farm productivity;

WHEREAS, the Municipality of Bustos, through its Municipal Agriculture Office, has identified the urgent need for two (2) four-wheel farm tractors and two (2) hand tractors to support rice farmers in land preparation and post-harvest activities;

WHEREAS, the Local Government Unit of Bustos commits to providing an owned shed for the secure storage of the machinery and allocating funds for their operation and maintenance, as certified by the Municipal Budget Office;

WHEREAS, the Municipal Budget Office has issued Certification attesting to the availability of PHP 150,000.00 under the Maintenance and Other Operating Expenses (MOOE) - “Support to Operation and Maintenance of Four-Wheel Tractor” under the Office of the Municipal Agriculture for Fiscal Year 2025;


