## RESOLUTION NO. 2025-77

**“AUTHORIZING THE HONORABLE FRANCIS ALBERT G. JUAN, MUNICIPAL MAYOR, TO RECEIVE ONE (1) PATIENT TRANSPORT VEHICLE FROM THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR) AND APPROVING THE USE OF ₱900,000.00 FROM THE FY 2025 MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE) FOR THE MAINTENANCE, REPAIR, AND OPERATIONAL COSTS OF THE SAID VEHICLE.”**

**WHEREAS**, the Philippine Amusement and Gaming Corporation (PAGCOR), through its Corporate Social Responsibility (CSR) Program, has granted the Municipality of Bustos one (1) patient transport vehicle to bolster healthcare services for its constituents;

**WHEREAS**, the Municipal Budget Office issued a certification confirming the availability of ₱900,000.00 under the Maintenance and Other Operating Expenses (MOOE) for Fiscal Year 2025, specifically allocated for Repair and Maintenance of Transportation Equipment and Fuel, Oil, and Lubricant Expense under the Bustos Community Hospital and Office of the Municipal Health;

**WHEREAS**, the aforementioned funds shall be utilized to ensure the operational readiness, upkeep, and sustainability of the donated patient transport vehicle, including but not limited to its repair, preventive maintenance, fuel, oil, lubricants, and other incidental expenses;

**WHEREAS**, Section 17 of the Local Government Code of 1991 (RA 7160) mandates local government units to prioritize public health services, including the provision and maintenance of essential medical equipment and vehicles;

**WHEREAS**, the Sangguniang Bayan, under Section 444(b)(1)(vi) of RA 7160, is authorized to empower the Municipal Mayor to accept donations and allocate funds for programs and projects beneficial to the municipality.




**THEREFORE**, upon motion by **HONORABLE ALJHANEAL E. QUIÑONES**, and unanimously agreed upon by all the members present.


