RESOLUTION NO. 2025-78

“AUTHORIZING THE HONORABLE FRANCIS ALBERT G. JUAN, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE PHILIPPINE ATMOSPHERIC, GEOPHYSICAL, AND ASTRONOMICAL SERVICES ADMINISTRATION (PAGASA) FOR THE ESTABLISHMENT, OPERATION, AND MAINTENANCE OF A RAIN GAUGE STATION IN BARANGAY MALAMIG, INCLUDING THE CONDUCT OF AN INFORMATION AND EDUCATION CAMPAIGN (IEC), AND APPROPRIATING FUNDS FOR THE PHYSICAL MAINTENANCE OF THE STATION.”

WHEREAS, the Philippine Atmospheric, Geophysical, and Astronomical Services Administration (PAGASA) is the national institution mandated to provide weather, flood, and climate-related services critical to disaster risk reduction and environmental sustainability under Republic Act No. 3521 and Republic Act No. 10121 (Philippine Disaster Risk Reduction and Management Act of 2010);

WHEREAS, the Municipality of Bustos recognizes the necessity of enhancing local disaster preparedness and climate resilience through accurate weather monitoring, particularly in flood-prone areas;

WHEREAS, the establishment, operation, and maintenance of a rain gauge station in Barangay Malamig will strengthen real-time weather data collection, enabling timely disaster response and mitigation efforts;

WHEREAS, an Information and Education Campaign (IEC) is essential to educate residents on the purpose of the rain gauge station, disaster preparedness protocols, and community participation in environmental monitoring;

WHEREAS, Section 17(c) of the Local Government Code of 1991 (RA 7160) empowers local government units to enter into agreements with national agencies to advance public welfare;

WHEREAS, Section 22(c) of the Local Government Code of 1991 stipulates that any agreement to be represented by the Municipal Mayor on behalf on the Municipal Government must be approved by the Sangguniang Bayan before it can be authorized.

THEREFORE, upon motion by **HONORABLE WILFREDO G. CANOZA**, and unanimously agreed upon by all the members present.

RESOLVED, as it is hereby **RESOLVED**, to authorize the Local Chief Executive, Honorable Francis Albert G. Juan, to enter into a memorandum of agreement (MOA) with the Philippine Atmospheric, Geophysical, and Astronomical Services Administration (PAGASA) for the establishment, operation, and maintenance of a rain gauge station in Barangay Malamig, including the conduct of an information and education campaign (IEC), and appropriating funds for the physical maintenance of the station.






