WHEREAS, rabies is a fatal but preventable viral disease transmitted through the bites of infected animals claiming hundreds of lives annually in the Philippines;

WHEREAS, Republic Act No. 9482 (Anti-Rabies Act of 2007) mandates local government units (LGUs) to prioritize rabies prevention through education, vaccination, and community engagement;

WHEREAS, the Municipality of Bustos recognizes the need to sustain public awareness on rabies prevention, given its rural setting and proximity to agricultural areas where human-animal interaction is frequent;

WHEREAS, designating a dedicated month for rabies awareness will galvanize Barangays, Schools, and stakeholders to unite in combating rabies through synchronized campaigns and activities.

THEREFORE, upon motion by **HONORABLE JULIET DELA CRUZ**, and unanimously agreed upon by all the member present.

RESOLVED, as it is hereby **RESOLVED**, to declaring the month of March as rabies awareness month in the Municipality of Bustos to intensify public education, prevent rabies transmission, and promote responsible pet ownership.


