**WHEREAS**, the Constitution of the Philippines (Article II, Section 15) mandates the State to protect and promote the right to health of its citizens;

**WHEREAS**, the Local Government Code of 1991 (Republic Act No. 7160, Sections 16, 17, and 102) devolves basic health service delivery to local government units (LGUs), empowers LGUs to promote the general welfare, and establishes the Local Health Board to oversee health programs;

**WHEREAS**, the Universal Health Care Act (Republic Act No. 11223, particularly Section 10, requires LGUs to formulate and implement a comprehensive Local Investment Plan for Health (LIPH) to achieve equitable access to quality health services;

**WHEREAS**, the Mandanas-Garcia Supreme Court Ruling (G.R. No. 199802) enhances fiscal decentralization, enabling LGUs like Bustos to strengthen local health systems through increased national tax allotments;

**WHEREAS**, the DILG-NEDA-DBM Joint Memorandum Circular No. 1, Series of 2007 provides guidelines for harmonized local planning, ensuring alignment of the LIPH and AOP with national and provincial development frameworks;

**WHEREAS**, the Municipality of Bustos, through its Municipal Health Board and Municipal Development Council, conducted participatory consultations with stakeholders, civil society, and barangay
