WHEREAS, the Office of the Municipal Mayor, through the letter dated 28 March 2025, requested this Sangguniang Bayan to urgently pass a resolution authorizing the Honorable Mayor Francis Albert G. Juan to enter into a Memorandum of Agreement with the Department of Education (DepEd) Schools Division of Bulacan represented by Schools Division Superintendent, Norma P. Esteban, EdD, CESO V, by virtue of DepEd Order No. 40 series of 2014 relative to a newly established public institution, the Tanawan Elementary School located at Barangay Tanawan, Bustos, Bulacan.

WHEREAS, Section 455, (a)(b)(1)(vi) of Republic Act No. 7160, otherwise known as the “Local Government Code of 1991,” mandates that the Mayor, as the Chief Executive of the Municipal Government, shall exercise such powers and perform as provided for by this code and other laws for an efficient, effective and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of this same code and shall represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon the authority of the Sangguniang Bayan pursuant to law or ordinance;

WHEREAS, DepEd Order No. 40 series of 2014 otherwise known as the "Establishment, Merging, Conversion and Naming/Renaming of Public Schools and Separation of Public Annexes in Basic Education" formulating a set of standard and uniform guideline while Section 3 of Republic Act No. 9155 also known as "Governance of Basic Education Act of 2001" the purpose and objective of which is to establish schools as facilities where school children can learn a range of core competencies prescribed for elementary and high school education programs;

WHEREAS, the Municipal Government of Bustos strongly supports the newly established public institution otherwise known as the Tanawan Elementary School and an amenable partner of DepEd national programs and is willing to allocate funds thru the Special Education Fund (SEF) to schools within its jurisdictions;

WHEREAS, there is a need to execute a memorandum of agreement delineating the scope of participation of the municipal government with the national program of DepEd;

WHEREAS, the roles and responsibilities of the contracting parties stipulated on the MOA is made an integral part of this resolution;


NOW THEREFORE, on motion by all the Sangguniang Bayan Members present


PROVIDED THAT, any and all obligations relating to the release, disbursement or expenditure of public funds, construction of public works, delivery of materials for public works and issuance of treasury warrants and similar devices, the appointment of new employees, creation of new position, promotion, or giving salary increases of in furtherance of the said Memorandum of Agreement shall take effect *only* after the period of election ban shall have expired and/or lifted.






