WHEREAS, the Department of the Interior and Local Government (DILG) awarded the Seal of Good Local Governance (SGLG) Incentive Fund for Fiscal Year 2024 to the Local Government Unit (LGU) of Bustos, Bulacan in recognition of its exemplary performance in governance, transparency, and service delivery;

WHEREAS, the SGLG Incentive Fund (SGLGIF) is granted to support local development projects that enhance public service efficiency and community welfare;

WHEREAS, the LGU proposes to utilize the One Million, One Hundred Fifty-Three Thousand Pesos (₱1,153,000.00) SGLGIF allocation for the acquisition of one (1) Rescue Vehicle to improve mobility in delivering critical services, including disaster response, health emergencies;
