WHEREAS, Joint Memorandum Circular No. 2, Series of 2021, issued by the Department of the Interior and Local Government (DILG), the Department of Social Welfare and Development (DSWD), and the Department of Education (DepEd), provides the Updated Guidelines for the Formulation of Local Disaster Risk Reduction and Management Plans (LDRRMP), which include the Early Warning System (EWS) and Camp Management Plan (CMP) as essential components;

WHEREAS, pursuant to the said circular, all Local Government Units (LGUs) are enjoined to develop and institutionalize Standard Operating Procedures (SOPs) for Early Warning Systems and Camp Management to ensure coordinated, timely, and efficient disaster preparedness and response;

WHEREAS, the Municipal Disaster Risk Reduction and Management Office (MDRRMO) of Bustos, Bulacan, has formulated its Standard Operating Procedure (SOP) for Early Warning System and Camp Management Plan to strengthen community readiness and enhance local response capabilities during emergencies and disasters;

WHEREAS, the said SOPs have been crafted in accordance with the standards, principles, and policy directives provided under Joint Memorandum Circular No. 2, Series of 2021, and are aligned with the needs and capacities of the Municipality of Bustos;

WHEREAS, it is imperative for the Sangguniang Bayan to formally adopt the MDRRMO's SOP for EWS and CMP to ensure their institutionalization, implementation, and integration into the Municipality's Disaster Risk Reduction and Management efforts.





APPROVED and ADOPTED, 4th day of June, 2025 by the Sangguniang Bayan at the Amado Raymundo Session Hall.






