**WHEREAS**, the Municipality of Bustos, through its agricultural support programs, aims to empower local farmer organizations and enhance agricultural productivity through the provision of equipment and machinery;

**WHEREAS**, a Ride-on Hand Tractor has been made available by the Municipal Government for use by organized farmer associations to improve farm mechanization and post-harvest efficiency;

**WHEREAS**, the Bustos Municipal Agriculture and Fishery Council has been identified as a qualified and duly registered farmers' organization capable of operating and maintaining the Ride-on Hand Tractor for the benefit of its members and the local farming community;

**WHEREAS**, to formalize the responsibilities and obligations of both the Municipal Government and the Bustos Municipal Agriculture and Fishery Council regarding the handling, proper use, and maintenance of the said machinery, it is necessary to enter into a Memorandum of Agreement (MOA);

**WHEREAS**, Section 22(c) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, authorizes the Local Chief Executive to enter into contracts and agreements on behalf of the local government unit, with prior authorization from the Sangguniang Bayan.
