“AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HONORABLE FRANCIS ALBERT G. JUAN, TO ENTER INTO A DATA TURNOVER AGREEMENT BETWEEN THE LOCAL GOVERNMENT UNIT OF BUSTOS AND THE PHILIPPINE STATISTICS AUTHORITY (PSA) RELATIVE TO THE COMMUNITY-BASED MONITORING SYSTEM (CBMS).”

WHEREAS, Republic Act No. 11315, otherwise known as the “Community-Based Monitoring System (CBMS) Act,” institutionalizes the adoption and implementation of CBMS by local government units to generate granular and updated data for use in local development planning and evidence-based governance;

WHEREAS, the Philippine Statistics Authority (PSA), as the lead implementing agency of CBMS, requires a formal Data Turnover Agreement with local government units to facilitate the transfer of CBMS data in accordance with data privacy laws and technical standards;

WHEREAS, the Local Government Unit (LGU) of Bustos, Bulacan has participated in the CBMS implementation and now intends to formalize the transfer and receipt of CBMS datasets and results through said agreement;

WHEREAS, the Data Turnover Agreement will define the roles, responsibilities, data access protocols, and usage conditions to ensure the responsible use, protection, and confidentiality of personal and household-level data collected through the CBMS;

WHEREAS, Section 22(c) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, authorizes the Local Chief Executive to enter into contracts and agreements on behalf of the local government unit, with prior authorization from the Sangguniang Bayan.





APPROVED and ADOPTED, 9th day of June, 2025 by the Sangguniang Bayan at the Amado Raymundo Session Hall.




