WHEREAS, the Local Government Unit of Bustos recognizes the importance of the Payapa at Masaganang Pamayanan (PAMANA) Program of the Office of the Presidential Adviser on Peace, Reconciliation and Unity (OPAPRU) in promoting inclusive development and sustaining peace in conflict-affected and vulnerable communities;

WHEREAS, one of the identified infrastructure projects under the PAMANA Program in the Municipality of Bustos is the Concreting of Barangay Malawak-Catacte Road, which will provide better access to basic services and improve local economic opportunities;

WHEREAS, in order to effectively implement and monitor the said project, a Memorandum of Agreement (MOA) between the Local Government Unit (LGU) of Bustos and OPAPRU is necessary;
